Burning Foot Beer Festival Food Vendor Application and Agreement

Dear Food Vendor,

This application and agreement is for the 2022 Burning Foot Beer Festival which will take place on Saturday August 27th at Pere Marquette Beach in Muskegon. If you make delicious food and serve it with incredible customer service, we'd love to have you join our event. We are anxious to confirm food vendors who feature a variety of different foods that do not overlap.

Important Notes & Rules for 2022 Burning Foot Beer Festival Food Vendors

- <u>Applications and Payment are due by July 1, 2022</u>. Any vendors that have not provided the application and payment by July 1, 2022 will not be considered for the 2022 event.
- We require a short description of your product distinguishing you from the other food vendors for the program and website. Imagine you're buying each word and making each word count.
- You can accept any type of payment and will be responsible for your own sales. You may only sell pop and water. No alcoholic beverages may be sold.
- Keep the sidewalk clear behind the food tent and enter from the back point entrance and deliver along the sidewalk tent.
- IMPORTANT SET-UP/TEAR DOWN INFO: All food trucks and booths <u>MUST</u> be set up on Friday, August 26 between the hours of 9am-4pm. On Saturday August 27 you can load in food or supplies until 10am. Tear down must be complete by Sunday, August 28 at 12:00pm.
- NEW!! We are working hard towards being a zero impact festival. To assist us
 in these efforts, we require that you use sustainable packaging. It will be a
 requirement that you are using compostable/greenware products for your
 servings utensils (I.E. Plates, Bowls, Forks, Napkins, Etc). We will confirm the
 day of the event by inspection that you are using these products otherwise
 you will not be allowed to serve.
- **NEW!!** You need to provide your own source of power, including a generator if needed, for the event.
- You need to provide your own ice, tables, and other items needed for your set up.
- Due to our festival insurance policy ALL volunteers/workers must be 21 years of age or older. NO EXCEPTIONS!
- Vendor Hours: Saturday, August 27, 2021 from 2pm to 10pm.
- Failure to comply with these rules will result in non-consideration for the next year, and may result in your food truck being shut down during the 2022 festival.

IMPORTANT DATES TO REMEMBER:

JULY 1, 2022- Vendor applications, proof of liability insurance, and payments due.

AUGUST 20, 2022- Send the names of your volunteer/staff to hospitality@lakeshoreguild.beer. Reminder - you are allotted a maximum of 8 Designated Driver wristbands, any additional will be at your cost.

AUGUST 26, 2022- set up day 9am-4pm. <u>You MUST be done setting up by 4pm and off</u> <u>premises, no exceptions!</u> Saturday morning you will only be allowed to bring in food/products. You must be ready to serve/ready for inspection at 10am.

AUGUST 27, 2022 - festival day. As previously stated, setup must be complete by 10am, and all vehicles moved out of the staging area, and ready to serve/ready for inspection.

AUGUST 28, 2022 - Tear down day. Reminder- tear down must be complete by 12pm.

- The licensee retains control over all portions of the licensed premises.
- The licensee will purchase all alcoholic beverages from an authorized source.
